Separate sealed tenders in plain papers from intending bidders are invited for sale of office vehicles bearing Regd. Nos. OD-05-D-0555 (Tata Indigo CS LE TDI- BS-III - AC) and OR-05-S-2222 (Qualis) of Odisha State Legal Services Authority, so as to reach the undersigned (through Regd. Post/ Speed Post/Courier Service or by hand) on or before **5 P.M. of 18-06-2019**. The cover containing the tender shall be super-scribed by the words "Tender for purchase of Indigo vehicle bearing Regn. No. OD-05-D-0555" or "Tender for purchase of Qualis vehicle bearing Regn. No. OR-05-S-2222". The intending bidders are to deposit EMD of Rs. 1000/- separately for each of the vehicle in shape of Bank Draft payable at SBI, Main Branch, Cuttack in favour of the Deputy Secretary, Odisha State Legal Services Authority, SO-20, Cantonment Road, Cuttack-753001 which should be enclosed along with the tender papers. The intending bidders may inspect the vehicle(s) at the Office of Odisha State Legal Services Authority Premises, SO-20, Cantonment Road, Cuttack- 753001 on any working day during the office hours. The tenders shall be opened on 19.06.2019 at 11.30 A.M. in the chamber of the undersigned in presence of the tenderers or their authorized agents. The highest bidder shall deposit 25% of the total bid amount immediately after the sale is over failing which the EMD shall be forfeited. The balance 75% of the bid amount shall be paid within a period of 7 days from the date of acceptance of tender, failing which the deposited amount shall be forfeited. The successful bidder shall remove the vehicle from the office premises of this Authority within 7 days from the date of depositing the full bid amount failing which the Authority will not be responsible for any damage, pilferage or loss and no claim in that regard shall be entertained by this Authority. The ground rent @ 1 % of the tender amount shall be charged per each day after lapse of the stipulated period of seven days till removal of the vehicle from the site. If the ground rent so charged exceeds the sale price deposited, the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent. The EMD of the unsuccessful bidders would be returned to them and the EMD of the successful bidder would be adjusted towards the bid amount.

The Authority reserves the right to reject or accept any or all tenders without assigning any reason thereof.
