# LEGAL LITERACY, AWARENESS AND EMPOWERMENT

## Delivery Based Mega Legal Services Camp

With a view to effect a paradigm shift from legal awareness to legal empowerment, the National Legal Services Authority has been pleased to introduce a new Module of legal services camps, and in implementation of the same, the Odisha State Legal Services Authority under the guidance of the Hon'ble Executive Chairman, OSLSA, and with the assistance and cooperation of the respective District Legal Services Authorities and District Administration of the concerned districts has organised 5 No. of Delivery Based Mega-Legal Services Camps during the period from January to June, 2018 on the following core themes :

1. **Legal Rights and Entitlements of Senior Citizens and Persons with Disabilities.**
2. **Protection and Enforcement of Tribal Rights.**
3. **Poverty Alleviation**

In those camps not only mass legal awareness was generated and spread but also the eligible persons of the target sections of the society got their names registered and received instant benefits under various welfare schemes.

## Programmes on Legal Literacy / Awareness

Pursuant to the Calendar of Activities drawn by the OSLSA outlining the common minimum programmes to be conducted during the year 2018, the field units at District & Taluk levels organised Legal Literacy / Awareness programmes on the following legal themes / subjects during January to June, 2018.

- (i) Rights of the Transgender involving transgender people.
- (ii) Constitutional rights and duties of the citizens involving Police Officers, Panel Lawyers, PLVs. etc.
- (iii) Cyber Laws involving Police Officers, Advocates etc.
- (iv) Claims Tribunal Agreed Procedure involving Police Officers, Advocates, PLVs. etc.
- (v) Observance of International Women's Day on 8.3.2018 with organization of Legal Literacy Camps on PC. and PNDT Act, POCSO Act, Victims Compensation Scheme, Sexual Harassment of Women at Workplace and other women specific laws involving Medical Officers, Police Officers, Protection Officers etc. Street Plays and Rallies were also organized involving Members of Students Legal Literacy Clubs, PLVs etc.



# MEGA LEGAL SERVICES CAMPS

## at CUTTACK and BHUBANESWAR

**T**wo mega camps, one each at Sunshine Field, Cuttack and BJB College Field, Bhubaneswar were organised simultaneously on 28.01.2018 on the core theme of "Legal Rights and Entitlements of Senior Citizens and Persons with Disabilities". In adherence to the instructions contained in the new Module of NALSA, different Government Departments concerned with implementation of the various welfare schemes of the Central Government and State Government, set up their respective stalls at the Camp site with their

Officials. Both the Camps were attended by more than 6000 persons of the Target Sections, out of whom 2829 number of eligible beneficiaries got their names registered in different Stalls. Instant assistance/benefit was provided to 598 number of beneficiaries at the camp sites. Hon'ble Kumari Justice Sanju Panda, Judge, Orissa High Court and Chairperson of High Court Legal Services Committee graced the camp at Cuttack, and Hon'ble Dr. Justice D.P. Choudhury graced the camp at Bhubaneswar.
