A. Assistance to Victims of Domestic Violence

* Success story:

The daughter of Siba Prasad Panda of Deogaon, Anandapur got married to Priyabrata Pani of village Kankili, Parjanga, Dhenkanal four years ago. After two years of marriage, the victim Dipika gave birth to a baby boy but was tortured physically and mentally by her in laws as well as her husband. Her husband also assaulted her physically several times, for which she has spent several days of her life without taking any food. When the torture became unbearable, Dipika returned to her father's home a year ago. In the meantime, Dipika came into contact of Akhaya Kumar Chakra, PLV of DLSA, Keonjhar and requested him to solve her problem. Then Dipika came to the office of DLSA, Keonjhar and filed an application before Secretary, DLSA, Keonjhar to settle the matter. Then immediately a negotiation meeting was arranged with her in-laws in the office of DLSA, Keonjhar. After three counselling sessions, both the husband and wife agreed to reside together peacefully. Dipika agreed to live with her in laws and Priyabrata agreed to take Dipika from her father's home. Both the husband and wife filed a joint agreement before the secretary DLSA, Keonjhar. PLV Akhaya Kumar chakra was engaged to keep watch on the matter. Accordingly as per the agreement Priyabrata came to village Deogaon, Anandapur and took Dipika and

her son to his house situated at village Kankili, Parjanga, Dhenkanal. The matter was intimated to DLSA, Keonjhar by both husband and wife. PLV Chakra is also constantly monitoring the matter. After 15 days both the husband and wife made a call to the DLSA, Keonjhar and expressed that they are leading a happy conjugal life and also added their gratitude towards DLSA, Keonjhar. DLSA, Keonjhar is always making efforts to provide service to the general public in every moment as per their requirements.






