- S.R.O. No. 155/2017—In exercise of the powers conferred under Section 29-A of the Legal Service Authorities Act, 1987 (39 of 1987), the Odisha State Legal Services Authority, do hereby make the following regulation to amend the existing schedule appended to Regulation 20(1) of the Odisha State Legal Services Authority Regulation, 1996, namely:—
- 1 (1) This regulation may be called the Odisha State Legal Services Authority (Amendment) Regulation, 2016.
 - (2) It shall come into force from the date of publication in the Odisha Gazette.
 - 2. The proviso to Regulation 20 (1) shall be deleted
- 3. In the Odisha State Legal Services Authority Regulation, 1996 (As amended by vide Regulation 2011), for the Sechedule, the following schedule shall be substituted—

TYPING/MISCELLANEOUS/INCIDENTAL EXPENDITURE FOR HIGH COURT

- Actual_incidental expenditure incurred by the panel advocates will be reimbursed provided
 it is supported by vouchers and a certificate is given to that effect by such advocate. If the
 incidental expenditure is not supported by vouchers, the Secretary of the concerned Legal
 Services Authority/Committee may fix and reimburse a reasonable sum considering the
 approximate expenditure which might have occurred looking to the nature of the case.
- 2. Single set of honorarium shall be payable in cases in which more than one legal aided persons are involved.

SUB-ORDINATE COURTS

- Actual incidental expenditure incurred by the panel advocates will be reimbursed provided
 it is supported by vouchers and a certificate is given to that effect by such advocate. If the
 incidental expenditure is not supported by vouchers, the concerned Legal Services Authority/
 Committee may fix and reimburse a reasonable sum considering the approximate
 expenditure which might have occurred looking to the nature of the case.
- 2. Single set of honorarium shall be payable in cases in which more than one legal aided persons are involved.

EFFECTIVE HEARING & NON-EFFECTIVE HEARING

- 1. 'Effective Hearing' means hearing on merits of the case.
- 2. 'Non-effective Hearing' includes adjournments on genuine grounds or at the instance of the Court but not mere listing/posting of the case without being taken up for hearing by the Court.
