Minutes of the meeting dated 04.06.2021 of the High-Powered Committee under the Chairmanship of Hon'ble Kumari Justice Sanju Panda, Judge, Orissa High Court and Executive Chairperson, Odisha State Legal Services Authority with regard to release of prisoners for decongestion of jails in view of spreading of Covid-19 disease, over telephonic conversation.

The Sixty-first meeting of HPC is convened through telephonic conversation by the following dignitaries:

- a. Hon'ble Kumari Justice Sanju Panda, Judge, Orissa High Court and Executive Chairperson, Odisha State Legal Services Authority.

In view of the rapid rise of COVID-19 infection in the community at present and also basing on the report of UTRC, Khurda and UTRC, Rayagada regarding 175 prisoners and 72 prisoners respectively being found COVID positive, the HPC directs the UTRC, Khurda and UTRC, Rayagada to remain more vigilant and to take steps for scaling down the rapid surge in infection in jails, ensure proper testing, treatment facilities for COVID positive prisoners, carry out sanitization on regular intervals and monitor the health of all the prisoners/staff who were exposed.

III. Report submitted by Directorate of Prisons and Correctional Services, Odisha

- i. The DG of Prisons & DCS, Odisha in his letter vide No. 10158 dated 03.06.2021 addressed to the Member Secretary, OSLSA referred to the order dated 31.05.2021 of the Hon'ble High Court of Orissa in W.P.(C) No. 6610/2006 (Krushna Prasad Sahoo-vrs-State & Others) in which the Hon'ble Court has expressed their concern about overcrowding in six Jails which includes District Jail, Phulbani, Special Sub-Jail, Bhadrak, Sub-Jail, Jajpur, Sub-Jail, Nayagarh, Sub-Jail, Parlakhemundi and Sub-Jail, Malkangiri during time of COVID- 19 pandemic which can pose a serious risk to the health and safety of the prisoners as well as the Jail staff. He has also brought to the notice of this Authority that, as on 31.05.2021, total 845 UTPs are lodged in different Jails of the state for the offences whose maximum prescribed punishment is imprisonment upto 7 years.
- ii. The IG of Prisons & CS, Odisha vide memo No. 10124 dated 03.06.2021 has intimated OSLSA that in compliance of the order dated 31.05.2021 of the Hon'ble High Court of Orissa in W.P.(C) No. 6610/2006 and W.P.(C) No. 3368/2014 the Superintendent of six Jails i.e. Parlakhemundi, Bhadrak, Nayagarh, Malkangiri, Phulbani and Jajpur where there is overcrowding have been requested to explore accommodating the prisoners from their jails at suitable government buildings with adequate security, secured boundary walls and to submit feasibility report.

Taking serious concern about overcrowding in six Jails i.e., District Jail, Phulbani, Special Sub-Jail, Bhadrak, Sub-Jail, Jajpur, Sub-Jail, Nayagarh, Sub-Jail, Parlakhemundi and Sub-Jail, Malkangiri, the Chairman, HPC directs the UTRCs Phulbani, Bhadrak, Jajpur, Nayagarh, Gajapati and Malkangiri to take urgent steps for decongestion of the Jails adhering to earlier directions of the HPC. The Chairman, HPC also instructs the D.G. Prisons to intimate regarding steps taken at their end for shifting of the prisoners from the overcrowded jails to some other Jails or to any other safe and secure premises. Till then, the concerned Jail authorities are to look after the health condition of all the prisoners so as to avoid the spread of COVID infection in the aforementioned Jails.

So far as lodging of 845 UTPs in different Jails of the state for the offences whose maximum prescribed punishment is imprisonment upto 7 years as intimated by the D.G. Prisons is concerned, the Chairman, HPC reiterates that the directives issued by the HPC on 21.05.2021 in its fifty-ninth meeting for release of prisoners by executing P.R. bond before the concerned Courts in appropriate cases should be followed by the stakeholders.

Further, the Chairman, HPC taking note of the gravity of the situation which requires immediate attention, requests the Principal Secretary, Home Department, Govt. of Odisha to ensure strict implementation of the directives of the Hon'ble Apex Court in Arnesh Kumar vs. State of Bihar by the Police Authorities or the arresting officers.
