In exercise of the powers conferred by the provisions of section 357A of the Code of Criminal Procedure, 1973, (2 of 1974), the State Government do hereby make the following amendments to the Odisha Victim Compensation Scheme, 2017, namely:-

- 1. (1) This Scheme may be called the Odisha Victim Compensation (Amendment) Scheme, 2018.
  - (2) It shall be deemed to have come into force with effect from the 2<sup>nd</sup> October, 2018.
- 2. In the Odisha Victim Compensation Scheme, 2017 (hereinafter referred to as the said scheme, in clause 2 in sub-clause (g) before the words 'and requires' and after the word 'crime' the words 'including mob violence and lynching' shall be inserted
- 3. In the said scheme,-
  - (a) the Schedule appearing at the end of "Schedule-I" and below the Schedule so named, the expression "Compensation scheme for victims of all crime other than women victims or survivors of sexual assault or other crimes" shall be inserted;
  - (b) In Schedule-
  - (i) Serial No. 2 and 9 shall be omitted.
  - (ii) in Serial No. 5, for the expression "Sexual Assault (Excluding rape)" appearing below column (2), the expression "Sexual assault (other than women victims)" shall be substituted, and
  - (iii) in Serial No. 11, for the expression "Acid Attack" appearing below column(2), the expression "Acid Attack (Other than women victims" shall be substituted.

4. In the said Scheme, following Schedule shall be inserted after Schedule-I, namely:-
