District Judge for filling up of 01 post of the Chairperson, Permanent Lok Adalat (PUS) for clustered districts. The tenure of appointment shall be for a maximum period of 05 years or till the age of sixty five years, whichever is earlier.

NO. OF CANDIDATE TO BE SELECTED : **1 (One)**

ELIGIBILITY :

- i. The applicant must have retired from service on superannuation in the cadre of District Judge by 31.12.2023.
- ii. A retired person holding judicial office higher in rank than that of District Judge may also apply for the post.
- iii. The applicant must be below the age of 65 years.

TERMS AND CONDITIONS :

The terms and conditions of appointment shall be governed by Section 22-B of the Legal Services Authorities Act, 1987 read with the provisions of Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and other Persons) Rules, 2003, as amended.

The selected Chairperson shall be entitled to a monthly fee of last drawn salary less the amount of pension received by him/her. He/She shall be entitled for other allowances, as admissible from time to time.
