H. Success Stories:

- 1. On dtd.13.03.2024, 6 Nos. of P.W. Ds have got automatic battery cycles with the help of P.L. Vs of D.L.S.A., Deogarh in a camp organised by DSSO, Deogarh under the AOIP scheme of Central Govt. The Secretary, O.L.S.A., Deogarh, M.L.A., Deogarh, the Chairperson, Deogarh Municipality were present in the said camp.
- 2. One P.L.V. has got a Railway Identity Card for Orthopedically Handicapped from E.Co. Railway, Sambalpur. He has also process for same Id. Card for other 2 persons.
- 3. THIS AUTHORITY ENSURED IN SECURING THE RIGHT OF A WIDOW IN THE MATTER OF FAMILY PENSION:

On 02.06.2023 the doors of this Authority were knocked by a 73-year-old widow lady namely Manjulata Mishra with tears shedding off her eyes and grieved off to the effect that she has been deprived of the family pensionwhich was ought to have been sanctioned post to the death of her Husband namely Umakanta Dash on 15.06.2021. It was further stated that her husband retired as Inspector from Co-Operative Society under Government of Odisha andwas drawing his pension till the date of his death but things turned around just after the death as she was not sanctioned with family pension by the department just because there was discrepancy in the surname of the deceased husband.

The old widow lady was crawling from pillar to post and the concerned officials were just shifting their responsibility upon one to the other and when the matter was brought to the notice of DLSA Khurda took efficacious steps and issued a letter to the registrar cooperative society vide Lr. No. 2536/Dtd.02.06.2023 calling for his appearance with relevant documents for conciliation and on 17.06.2023 the conciliation was taken up in presence of Administrative Officer and the applicant. After the discussion on length was revealed that due to the mismatch in surname the Family Pension could not be sanctioned, further, this Authority directed the Tahsildar, Chillika vide Lr. No. 3101/Dtd.05.07.2023 to cause an inquiry to the effect that Late Umakanta Mishra and Umakanta Dash are one and same person and submit report to DLSA Khurda, Simultaneously the department was directed to take steps at their end in computing the family pension.

Upon receipt of the report from the Tahsildar Chillika wherein he held that Late Umakanta Mishra and Umakanta Dash are one and same person and the report was submitted to the Commissioner-cum-Secretary, Department of Cooperation, Govt. Of Orissa vide Lr. No. 5098/Dtd.19.10.2023 and requested for taking efficacious steps in sanctioning the same relying on the report of tahasildar.

Finally, on 19.02.2024, Registrar Cooperative Society sanctioned provisional family pension in favour of the applicant Smt. Manjulata Mishra vide its Sanction No. 202333290907/dtd.19.02.2024 and the sanction was only possible on repeated and consistent intervention of DLSA Khurda vide letter no. 5516/Dtd.17.11.2023, 872/dtd.08.02.2024.

4. APPRECIATION TO THIS AUTHORITY BY HON'BLE HIGH COURT OF ORISSA:

Been directed by Hon'ble Court in BLAPL No. 738/2024 communicated to this Authority vide issue No. 5330/dtd.20.02.2024, that the DLSA to produce the victim namely Smruti Ranjan Mallick before Special Medical Board Capital Hospital, Bhubaneswar on 21.02.2024 at 11:30 AM.

In pursuance thereof, DLSA Khurda took pro-active steps in complying with the directions of Hon'ble Court, DLSA Khurda in ascertaining the where abouts of the victim issued a letter to Secretary, DLSA, Jajpur vide letter No. 955/dtd.20.02.2024 calling for the address and contact number of the victim as the matter is pending in the file of SDJM, Jajpur, upon receipt of the information from the DLSA, Jajpur, DLSA Khurda contacted the victim over telephone which was answered by his wife and his wife stated that the victim is bedridden and in comma since days and they are residing in Tankapani Area, Bhubaneswar.

Upon informed of such condition of the victim, DLSA Khurda issued a Letter Vide Lr. No. 1009/dtd.20.02.2024 to The Director, Capital Hospital to extend ambulance service for to and fro movement of the Victim from his place of residence to the Hospital and simultaneously a Para Legal Volunteer namely Padmalochan Mohanty was deputed for smooth facilitation in the matter.

On 21.02.2024 the PLV submitted its report that he accompanied the victim in the ambulance and the victim was produced before the board along with his wife, the examination was undergone by the board and the pursuant thereto the victim was sent to his residence.

The compliance report along with the Medical Examination report in sealed cover was submitted to the Hon'bleCourt for kind perusal and consideration.

On 07.03.2024 Hon'ble Court was pleased to appreciate DLSA Khurda in its Order No. 3 and Para No. 15A "that the efforts made by the Ld. DLSA Secretary in facilitating such examination of the victim by medical Board is commendable.

5. HOUSE OF A PERSON H AS SAVED FROH BEING GRABBED IN THE GARB OF AUCTION:

Upon receipt of a grievance from the applicant namely Anita Sahoo regarding Harassment by Punjab and Sind Bank, Ashok Nagar Branch, Bhubaneswar through E-Mail on 18.03.2024, pursuant thereto the AGM of the Bank was noticed to appear with relevant documents for conciliation and conciliation was taken up on 20.03.2024 and on 21.03.2024 been attended by the Representative of AGM and BM on 20.03.2024 and the AGM himself with the BM on 21.03.2024.

The crux of the dispute which revolves around is the bank published an auction notice in the newspaper terming defaulter to the applicant on the loan accounts upon which there remains no amount as overdue and consequent upon it to go with the auction process of the mortgaged property.

On the verge of conciliation, it was revealed by the bank that the husband of the applicant had availed amudra loan from Jayadev Vihar Branch of Punjab and Sind Bank, which was made OTS on getting the proposal from the Bank. Further, the bank stated that unless the husband of the applicant calls off for the OTS proposal the loanaccounts could not be renewed and auction process would not be stopped, further, the bank admitted that once aloan has been sanctioned by the bank on creation of an equitable mortgage before a branch of a bank in the year 2010 then Loan under Mudra scheme in the year 2017 would not have been sanctioned.

On completion of the conciliation process which was refused by the bank to call off the Auction notice thematter was brought to the notice of Chief Vigilance Officer and the Zonal Manager of the Bank by this Authority as the loan under Mudra Scheme would not have been sanctioned and it being an Inter-se matter by and between the Jayadev Vihar Branch and Ashok Nagar, Punjab and Sind Bank the applicant should not suffer, vide Memo No. 1679/dtd.21.03.2024 and Memo No. 1680/dtd.21.03.2024 respectively and in response to the same the Auction Notice was called off.

Hence, the house of the applicant was saved from being grabbed on the pretext of Loan.

6. MEDIATION PROCESS IS THE ULTIMATE TOOL IN SPEEDY DELIVERY OF JUSTICE:

This Authority was approached for a Pre-Institution Mediation by the applicant IOBI Bank, Khurda Branch for recovery of money to a tune of Rs.6,89,680.37 from the 0.P.s., upon institution of the same the 0.P.s were noticed and in pursuance to the notice the O.P.s. appeared and consented to take apart in the Mediation Process.

Mediator was appointed and mediation process was taken up and on consistent joint efforts by the Coordinator Mediation Centre and Mediator the matter between the parties is resolved and Mediation process ended in positive and the stuck money of bank was recovered.
